The Committee shall determine the category/class of prisoners who may be considered for release on Parole or Interim Bail for such period as may be thought appropriate, depending upon the nature of offence, the number of years to which he or she has been sentenced or severity of the offence with which he/she is charged with and is facing trial or any other relevant factor, which the Committee may consider appropriate.
- 4. The Committee, while considering the cases of prisoners for parole or interim bail, shall take into account the directions contained in para-11 of the order passed in Arnesh Kumar vs. State of Bihar, (2014) 8 SCC 273.
- 5. The Committee may devise an appropriate mechanism for fulfilling its objectives.
