In terms of Govt. order No. 810-JK-(GAD) of 2020 dated 01.09.2020, sanction is hereby accorded to the constitution of Survey Committee comprising of following officers for the Survey of un-serviceable Departmental vehicles, Equipment, MT store items, obsolete stores and other articles damaged due to any incident or natural calamity or by way of normal and usual wear and tear for their condemnation in terms of Rule-217 of GFR-2017:-

6.	External Technical member/expert to be drawn from any Govt. Department, nominated by the Director, FSL in consultation with the concerned Department, depending on the nature of stores.	Member

The above Committee shall inter-alia satisfy itself with regard to the following conditions:-

1. Whether the store items/vehicles have outlived their prescribed life or covered prescribed mileage and have become un-serviceable after fair use.
2. Whether the Store items/ vehicles have got damaged un-serviceable due to any incident or natural calamity.
3. Whether the store items/ vehicles are beyond economical repairs and cannot be retrieved after repairs.

4. Whether any negligence found on the part of concerned official/ In-charge custody or due to the system failure in the maintenance.
5. Whether the condemnation to be recommended is strictly as per the provisions of the GFR-2017.

The Survey Committee after conducting survey shall make appropriate recommendations to the Director, Jammu and Kashmir Forensic Laboratory (FSL). Subsequently the Director FSL after scrutiny shall forward the proposal to Administrative Department with the recommendation(s) for issuance of Condemnation Sanction, followed by Auction.


