Subject: - Tentative Seniority list of the members of the Jammu and Kashmir Police (Gazetted) Service.

**Government Order No: 997-Home of 2019
Dated.01.10.2019**

Whereas, a final seniority list of Dy.SsP (Executive cadre), as it stood on 01.01.2011, was issued vide Government Order No. Home-687(P) of 2011 dated 01.07.2011; and

2. Whereas, some officers appointed as Dy.SP by way of direct recruitment in the year 1999 had approached the Hon'ble High Court through writ petitions viz. SWP No. 1620/2008 titled Shakti Pathak and others vs. State and others and SWP No. 3065/2010 titled Anita Sharma and others vs. State and others, which were clubbed and the Hon'ble Court vide common judgment dated 22.12.2011 was pleased to pass the following directions:

“....The respondents 1 to 5 are directed to undertake a fresh exercise to fix the date of promotion of the private respondents as Dy. SsP in compliance of writ court judgment dated 29.11.2004 upheld by the Supreme Court on 05.12.2007, consequent thereupon the date of their placement in the Selection Grade and as SP, after giving a fair and adequate opportunity to the parties to project their stance.....”

3. Whereas, pursuant to the above judgement of the Hon'ble High Court, various representations were received, which were examined and a tentative seniority list of Dy. SsP , as it stood on 01.08.1999, was notified, vide Circular No 18-Home of 2013 dated 24.10.2013, inter-alia, inviting objections. In response, 63 representations were received and these representations and all connected matters were examined by a Committee, under the chairmanship of Mr. S.P. Vaid, IPS, the then ADGP Hqrs, constituted vide Government Order No. 33-Home of 2015 dated

07.08.2015. While its recommendations were being considered, two officers, namely, Mr. Aftab Ahmad Kakroo and Mr. Ramesh Kumar Jala approached the Hon'ble Court, seeking a direction for restraining the respondents from issuing final seniority list without complying with SRO- 210 of 1994 and for finalizing the seniority of DySsP/SsP by giving due benefit of Rule 3 of the SRO ibid and maintaining the seniority of petitioners as was existing in the year 2010; the petitioners further contended that as per SRO-210 of 1994, reserves be utilized; and

4. Whereas, vide judgment dated 02.02.2017 the Hon'ble High Court disposed off the petition SWP No.139/2016 titled Aftab Ahmad Kakroo and another vs. State of J&K and others with direction to consider the objections to the tentative seniority list (ibid) and finalize the same after giving them an opportunity of being heard; and

5. Whereas, a Committee under the chairmanship of Mr. A. G. Mir, IPS, the then ADGP, CID, J&K, was constituted, vide Government Order No. 534-Home of 2018 dated 19.04.2018, for suggesting a concrete roadmap to resolve the issue of seniority of the members of J&K Police (Gazetted) Service [Executive Cadre] after holding consultations with all the stakeholders and affording them opportunity to project their view points; and

6. Whereas, the Committee submitted its report, vide No: PHQ/ADGP (HQ)-2018/1254 dated 08.10.2018, read with supplementary report dated 09.02.2019 , observing, among other things, that the J&K Police (Gazetted) Service Recruitment Rules, 1977 were notified vide SRO-33 of 1977 dated 19th January, 1977 and these Rules came to be replaced by the Jammu and Kashmir Police (Gazetted) Service Recruitment Rules, 1984, notified vide SRO-549 of 1984 dated 19th October 1984, which, however, were subsequently kept in abeyance, vide SRO-166 of 1985 dated 22nd April, 1985. The Committee further observed that even though the Rules of 1977 did not have a provision for reserves, the State Government, while notifying the revised J&K Police (Gazetted) Recruitment Rules in the year 1984, had provided for reserves in the service, vide SRO 549 of 1984 dated 19.10.1984. Further, taking note of Government Order No. GR-349(Police) of 1986 dated 26.09.1986, in terms whereof reserves were sanctioned for the J&K Police (Gazetted) Service, the Committee recommended that the Gazetted Services Recruitment Rules of 1977 have to be read in conjunction with Government Order of 1986 dated 26.09.1986 and SRO 210 dated 05.10.1994 of General Administration Department. Based on the above, by way of operation of the reserves from the date when SRO-210 dated



05.10.1994 was notified, the Committee worked out the eligibility list and proposed revision in the dates of promotion of Dy.SsP and their *inter-se* position, on the basis of revised dates of their promotion, as on 01.08.1999; and

7. Whereas, the recommendations submitted by the aforesaid Committee were further examined, more specifically in light of the directions /observations of the Hon'ble Court in Anita Sharma and Aftab Kakroo matters with regard to applicability of recruitment Rules and reserves at different points of time, including Government Order No.GR-349(POLICE) of 1986 dated 26.09.1986, SRO-210 of 1994 dated 05.10.1994 and provision of reserves in the Recruitment Rules from time to time. The Home Department proposed to utilize the reserves sanctioned in the Government order of 1986 but only with effect from 1994 i.e. the date of issuance of SRO-210. The matter was referred to the Department of Law, Justice and PA for advice and this view was concurred upon by the Department of Law, Justice and PA, vide U.O No. LD(Lit)2016/66-Home dated 12.09.2019, which also quoted specific observations of the Hon'ble High Court in Aftab Kakroo case which reads as under:

"determination of seniority of members of any service is the job of the concerned competent authority it is not the Court's job. If the court would proceed to meddle in the process of determination and finalization of the seniority of the members of a service, then I am afraid the job will never be accomplished. Yes, it is reiterated. Once the seniority is finalized by the competent authority if some member of the service is aggrieved by the position assigned to him , he can challenge the same with positive averments and particulars as to what his seniority position ought to be and why....."

8. Whereas, taking due care of the law laid down in Suraj Prakash Judgment in regard to allocation of quota, the eligibility requirements for promotion, applicability of reservation rules at the relevant point of time and in order to settle the long pending dispute which has very adversely impacted the cadre management and career progression of the members of the Service, also leading to adhocism, a detailed exercise was carried out and proposals related to the review in the dates of promotion of Dy.SsP earlier promoted w.e.f 01.01.1994, finalization of seniority list of DySsP as on 01.01.2000, review in the dates of promotion of SsP, review in the dates of promotion of DySsP from 01.01.2000 to 01.08.2005 and regularization of I/C Dy.SsP working on officiating basis after 01.08.2005 upto 01.02.2009

were placed before the State Administrative Council, while seeking exemption from referring the matter to the Jammu and Kashmir Public Service Commission (JKPSC); and

9. Whereas, the State Administrative Council vide its Decision No.25/21/2019 dated 13.09.2019, approved the aforementioned proposals; and

10. Whereas, consequent upon the above, vide Government Order No. 992-Home of 2019 dated 28.09.2019, a final seniority list of Dy.SsP (Executive cadre), as on 01.01.2000 has been issued. Further, vide Government Order No. 994-Home of 2019 dated 28.09.2019, sanction has been accorded to the review in the dates of promotion of officers who had been promoted as Dy.SsP from 01.01.2000 to 01.08.2005 and also, vide Government Order No. 995-Home of 2019 dated 28.09.2019, sanction was also accorded to the regularization of I/c Dy.SsP as Dy.SsP, w.e.f 01.07.2003 to 02.01.2009; and

11. Whereas, subsequent to the year 2000, some members of the service have been appointed through Combined Competitive Examination in the year 2001, 2004 and 2008 respectively; and

12. Whereas, in pursuance of Rule 9 of J&K Police (Gazetted) Service Recruitment Rules, 2002 notified vide SRO-132 of 2002 dated 3.4.2002, it is imperative to maintain an upto date seniority of the members of the service in terms of Rule 24 of J&K Civil Services (Classification, Control and Appeal) Rules, 1956; and

13. Now, therefore, in pursuance of the Rule 9 of J&K Police (Gazetted) Service Recruitment Rules, 2002 notified vide SRO. 132 of 2002 dated 03.04.2002 and in supersession of Government Order No. Home-687(P) of 2011 dated 01.07.2011, a tentative seniority list of the Deputy Superintendents of Police (Executive), as it stood on 02.01.2009, forming annexure to this Government Order, is hereby circulated among all the members of the service for their information.

14. Any officer having any objection to his/her inter-se seniority position may submit representation with documentary evidence in support of the claim, within a period of 21 days from the date of issuance of the aforesaid tentative seniority list. No representation(s)/objection(s) in the matter shall be entertained/considered after expiry of the stipulated period.

15. The issuance of the above tentative seniority list shall be without prejudice to the outcome of writ petition(s), if any, pending before competent court(s) of law.

16. The date(s) of birth indicated in the tentative seniority list shall be subject to the entries recorded in the individual Service Book/date of birth certificates. The officers belonging to reserved categories may submit an authenticated copy of the category certificate, in case of any discrepancy.


