Consequent upon the above, it is directed that the above PPs/APPs shall take over all the case files etc. of the respective Courts from the PPs/APPs, appointed by the Department of Law, Justice and Parliamentary Affairs, inventorise the same and take further steps for effective prosecution.

Further, for smooth transition and effective prosecution:-

- the Law Department shall ensure that the existing staff in the respective offices of the PPs/APPs continues to provide requisite assistance to the newly appointed Public Prosecutors/Additional Public Prosecutors;
- the existing staff provided by the Police Department for assistance of the CPOs shall also continue on as is where is basis, out of which, the Assistant PPs shall be continued to be provided the staff, as per their functional requirement, till further orders.
- 3. the respective District SsP shall facilitate the newly appointed Public Prosecutors/Additional Public Prosecutors by providing all requisite assistance.
