- i. the payment of such honorarium shall not exceed the total pay of one month of the officer/personnel concerned & will be applicable only to the CAPF/SAP personnel deployed on the election duty; and
- ii. the expenditure incurred on this account will be borne by the Chief Electoral Officer, J&K, under Major Head 2015-Election (Demand No. 10), Sub Major Head -00, Minor Head-102-Electoral Officers, Group Head-0099 General, Sub Head-0493-Chief Electoral Officer, Detailed Head-094-Election to Parliament/ Assembly.


