**Dated: 29.05.2019**

Whereas, as per the report received from the Director General of Prosecution, J&K, Mr. Waseem Ahmad Qureshi, Assistant Public Prosecutor in the Court of Judicial Magistrate, Ukhral (Prosecuting Officer), while on his way from Rajouri on 04.05.2020 was found to be in possession of 08 grms. of contraband, by the Police party of Rajouri; and

Whereas, on this account a case FIR No. 230/2020, under section 8(a), 21/29 NDPS Act, 1985, has been registered in Police Station, Rajouri, against Mr. Waseem Ahmad Qureshi; and

Whereas, it has been informed that the accused officer was detained and remained in custody for more than 48 hours and still continues to be on judicial remand; and

Whereas, on account of having remained in Police custody for more than forty eight hours, Mr. Waseem Ahmad Qureshi, is required be placed under suspension, in terms of the provisions of Civil Services (Classification, Control and Appeal) Rules, 1956.

Now, therefore, pending further enquiry into the conduct of Mr. Waseem Ahmad Qureshi, Assistant Public Prosecutor in the Court of Judicial Magistrate, Ukhral (Prosecuting Officer), he shall be deemed to have been placed under suspension w.e.f. 04.05.2020 i.e. the date since when he has been in custody.
