Sanction is hereby accorded to the temporary appointment of Ms. Sapna Khajuria, sister of Late PSI Sunil Kumar Khajuria, PID No. EXJ-096483 R/o A/P Lane No.3, Behind A.G.Office, Shiv Nagar, Jammu as Class-IV (Laboratory Attendant), in the Pay Level of SL-2 (15900-50400), in Directorate of Forensic Science Laboratory, J&K, Jammu, in terms of Provisions of SRO-43 of 1994.

The appointee shall report to Director, Forensic Science Laboratory, J&K, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- (i) Academic Qualification Certificate.
- (ii) Date of Birth Certificate.
- (iii) Domicile Certificate.
- (iv) Health Certificate from the concerned Chief Medical Officer of the District.
- (v) Dependent Certificate issued by the Assistant Commissioner, Revenue.
- (vi) No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- (vii) All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

- (a) That she shall give an undertaking in the shape of an Affidavit to the effect that:-
 - (i) In case an adverse report about her Character and Antecedents is received from the Additional Director General of Police (CID), J&K, to whom a reference shall be made by the Directorate of Forensic Science Laboratory, J&K, Jammu, she shall have no right to claim her appointment, which, shall be deemed to be have been cancelled ab-initio;

- (ii) If, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the appointment shall be treated to have been cancelled ab-initio.
- (b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.
