Whereas, vide Government Order No.197-Home of 2020 dated 22.09.2020, sanction was accorded to the regularization/promotion of 335 I/c Deputy Superintendent(s) of Police as Deputy Superintendent(s) of Police, from various dates indicated against each in the said order; and

Whereas, in terms of the ibid order, the services of Mr. Rajinder Kumar, 4028/NGO, as Deputy Superintendent of Police, were among others, regularized w.e.f. 11.07.2014; and

Whereas, the PHQ vide order No. 3365 of 2019 dated 14.09.2019, has re-fixed the seniority of Mr. Rajinder Kumar, (4028/NGO) at S. No. 471-A, in the Final Seniority List of the Inspectors, notified vide order No. 2999 of 2019 dated 31.07.2019, above Shri Abdul Rashid Khan (S.No.472), warranting review of the date of his regularization.

Now, therefore, sanction is hereby accorded to the regularization/promotion of Mr. Rajinder Kumar, 4028/NGO, as Deputy Superintendent of Police, w.e.f 08.02.2011, instead of 11.07.2014.

This shall, however, be without prejudice to the outcome of writ petition(s), if any, on the subject, pending in the competent Court(s) of law.


