Pursuant to the approval of the President, Rajya Sainik Board, sanction is hereby accorded to the appointment of **Cdr. Girdhari Lal** as Zila Sainik Welfare Officer [Pay Level 6F (Rs. 40800-129200)] in the Jammu and Kashmir Sainik Welfare (Gazetted) Service, with immediate effect.

It is further ordered that:-

- i. the terms and conditions of the appointment shall be governed by the Jammu and Kashmir Sainik Welfare (Gazetted) Service Recruitment Rules, 2019 and contract agreement executed by him in terms of clause (f) of Rule 10 of the said rules;
- ii. the appointment shall be for a period of three years from the date of appointment or upto the age of 60 years, whichever be earlier and shall be further subject to the satisfactory performance; and
- iii. the postings/transfers shall be effected as per the administrative requirements. The salary of the appointee shall be drawn and disbursed from the date of joining at the place of his posting, which shall be ordered separately.

It is further ordered that in case the appointee fails to join within a period of 21(twenty one) days from the date of issuance of the appointment order, he shall forego his right to appointment which shall be deemed to have been cancelled abinitio without any further notice.


