Whereas, the Police Headquarter vide the communication under reference submitted case of Shri Nazir Ahmad, Sgct, PID No EXK-983984, for adoption of the date of birth of official as 01.01.1975 instead of 01.01.1973; and

02. Whereas, the PHQ has furnished a certificate issued by the Jammu and Kashmir State Board of School Education (JKBOSE), in support of the case; and

03. Whereas, on the basis of the information and other relevant documents relevant to the case, it came to fore that Shri Nazir Ahmad, was initially appointed as Constable in JKP, in the year 1998, vide DPO Order No. 782 of 1998 dated 10.12.1998, and during preparation of the Character Roll, his date of birth came to be recorded as 01.01.1973 (First January N.H. and Seventy Three) on the 1st page of character Roll, and there is no mutilation/overwriting; and

04. Whereas, the case was examined and it came to fore that Shri Nazir Ahmad, was initially appointed as Constable in JKP, in the year 1998, vide DPO Order No. 782 of 1998 dated 10.12.1998, and during preparation of the Character Roll, his date of birth came to be recorded as 01.01.1973 (First January N.H. and Seventy Three) on the 1st page of character Roll and there is no mutilation/overwriting; and

05. Whereas, the case was examined in light of the factual details, documents made available by the PHQ and the extant rules governing the subject. It was observed that the designated committee in PHQ has not considered the relevant rule position as envisaged in Rule 192 & 193 of Police Rules 1960, and the provisions governing alteration of date of birth provided in Article 35-AA of Jammu & Kashmir Civil Services Regulation, 1956 and Rule 6.4 of the J&K Financial Code Volume-1; and



06. Whereas, it was further observed the official has failed to make a representation for alteration of recorded date of birth within five years of entry into government service viz before the year 2004, as envisaged under provisions of law.

Now, therefore, the claim of the applicant namely Shri Nazir Ahmad Sgct PID No EXK-983984, having been considered, in terms of **Rule 35 AA (C) of Jammu & Kashmir Civil Services Regulation Volume-I, Rules 6.4 of the J&K Financial Code read with Rule 192 & 193 of Police Rule 1960**, is found devoid of any merit and accordingly rejected. The date of birth of the official recorded on the Character Roll, shall continue to be treated as **01.01.1973**.
