**Subject: Reorganization of Crime Branch of the Jammu and Kashmir Police - reg**

**Government Order No. 130 -Home of 2020**  
**D a t e d: 23.06.2020**

In order to enhance the investigating capabilities of the Crime Branch and restructure it on the modern lines, sanction is hereby accorded to the reorganization of Crime Branch into the following Wings:

- I. Economic Offences Wing (EOW).
- II. Special Crime Wing (SCW).
- III. Cyber Crime Investigation Center for Excellence (CICE).
- IV. Anti Narcotics Task Force (ANTF).

It is further ordered that:

- (i) there shall be two units of the Economic Offences Wing, with Headquarters at Srinagar and Jammu, respectively.
- (ii) Special Crime Wing shall also have a similar set up as (a) above.
- (iii) each of these divisional Units, as also the CICE and ANTF, shall be headed by a Superintendent of Police.
- (iv) the Crime Headquarters shall discharge the responsibilities of Intelligence, Training and Policy, CCTNS, etc.

With a view to operationalize the aforesaid Wings, sanction is also accorded to the:


- (i) transfer of 85 posts of various ranks, as per the details below, from the erstwhile Anti-hijacking Unit to the Crime Branch:

- (ii) transfer of 10 posts of Deputy Superintendent of Police (Executive) from the overall reserves of the Jammu & Kashmir Police (Gazetted) Service to the Crime Branch.

The distribution *inter-se* of the above posts, alongwith the posts already sanctioned for the Crime Branch, shall be made in consultation with the PHQ.
