**Dated: 08.12.2020**

Whereas, the IGP, Kashmir Zone, being the Authorized Officer under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, has issued directions to the Telecom Service Providers (TSPs)/Internet Service Providers (ISPs) to suspend 2G mobile data services in the following Districts for the duration, as indicated against each, on 07.12.2020:

Police District, Awantipora	0100 Hrs.to 1700 Hrs.
District Shopian	0100 Hrs.to 1820 Hrs.
District Kulgam	0100 Hrs.to 1820 Hrs.
District Anantnag	0100 Hrs.to 1820 Hrs.
District Pulwama	0100 Hrs.to 2100 Hrs.

Whereas, the order/letter under reference inter-alia mentions about the apprehensions of misuse of data services by the anti-national elements to disrupt the polling process of the District Development Council (DDC) elections, scheduled in entire South Kashmir Range on 07.12.2020. It is further mentioned that fallacious material through social media had already started circulating, urging the public not to participate in the ongoing election process.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to the Government, Home Department, being satisfied that there was absolute necessity of issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty and integrity of India, the security of the State and for maintaining public order, hereby confirm order No. 4052(TSTS) of 2020 dated 07.12.2020, under endorsement No. KZ/CS/PC-Sgr/20/3121-22 dated 07.12.2020, issued by the Authorized Officer, in exercise of powers conferred under sub-rule (1) of Rule 2 of the Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017.
