**Whereas,** the case was placed before the Designated Committee (DOB Committee) at PHQ and on examination of the records, the Committee recommended for adoption of DOB of aforesaid official as **09-10-1963** as per Date of Birth Certificate issued by JKBOSE. duly verified by JK BOSE authority which reveals the date of birth of the retired official as **09-10-1963**; and

**Whereas,** the said official has already expired on 01.12.2022, due to natural death while in active service and stands struck off from the roll of the Police Department by Commandant IRP-21<sup>st</sup> Battalion, vide their Office Order No. 261 of 2022 dated 08.12.2022; and

**Whereas,** the issue regarding his date of birth needs to be settled at the earliest, so that his pension case can be finalized and his family does not suffer on this count; and

**Whereas,** documents relied upon for recording date of birth at the time of his initial appointment in JKAP 8th Battalion in the year 1983, as per report of Armed Police Headquarters, J&K, is his matriculation certificate, whereunder, date of birth has been shown as 09.10.1963; and

**Whereas,** the J&K State Board of School Education, new Campus, Bemina Srinagar, vide letter No/F/JS-Ver) B/KD/2023/F-7298 dated
