Sanction is hereby accorded to the:

- i. Revalidation and subsequent release of funds to the tune of Rs.1659.80 lakh along with Advance drawal of equal amount under Detailed Head 115- Works, Sub-Head 0704- Modernization of Police related to Major Head 4055- Capital Outlay on Police, in favour of Director General of Police, J&K for the current fiscal 2022-23.
- ii. Revalidation and subsequent release of funds to the tune of Rs.1783.35 lakh along with Advance Drawl of equal amount under Detailed Head 010-M&S, Sub-Head 0704- Modernization of Police related to Major Head 4055- Capital Outlay on Police, in favour of Director General of Police, J&K for the current fiscal 2022-23.

The sanction shall be subject to the following terms and conditions:

- i. The funds need to be mandatorily credited to the respective SNA Account in view of the instruction that all the expenditure under CSS is to be incurred from SNA Account as PFMS will not accept Treasury data of Non-SNA release w.e.f 01.12.2022.
- ii. The terms and conditions stipulated in BEAMS generated Order be adhered to in letter and spirit.
- iii. The expenditure shall be incurred on the admissible items only, as approved by the Ministry of Home Affairs, Government of India, after observing all the required codal formalities and due tendering process at all levels as envisaged in GFR-2017.
- iv. Red/Adjustment accounts are rendered to the Accountant General within the prescribed time limit.

- v. No diversion of funds at any stage is permissible.
- vi. The fund shall not remain idle in the SNA Account.
- vii. The Financial Advisor/CAO PHQ shall vouchsafe the availability of funds for the purpose.
