
Pursuant to the selection made on the basis of the Competitive Examination as prescribed under Jammu and Kashmir Competitive Examination (Prosecution) Rules, 2021 and on the basis of the recommendations made by the Jammu and Kashmir Public Service Commission, sanction is hereby accorded to the temporary appointment of the candidates as mentioned in **Annexure-I** to this Order, against the posts of Prosecuting Officer (G) in Jammu and Kashmir Prosecution Service, in the Pay Level 8 (47600-151100), with immediate effect.

The appointees shall report in the office of Director Prosecution, Jammu/Kashmir as per their preference.

The appointees shall be allowed to join only on production of the following certificates in original:

1. Date of Birth Certificate.
2. Qualification Certificate(s).
3. Domicile Certificate.
4. Relevant Category Certificate.
5. Any other documents as required under rules

The candidates who fail to join within a period 21 (twenty one) days from the date of issuance of this appointment order, shall forego their right to



appointment which shall be deemed to have been cancelled ab-initio without any further notice.

The salary of the appointees shall not be drawn and disbursed unless satisfactory reports in respect of genuineness of various certificates viz. Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agencies.

The appointment of the selected Candidates shall be governed by the following conditions:

- (i) These appointments shall be under "New Pension Scheme" notified vide SRO-400 of 2009 dated 24.12.2009.
- (ii) The appointees shall be on probation for a period of two years.
- (iii) The appointment of all the candidates shall be subject to outcome of the writ petition(s)/O.As/Appeal, if any, pending before any Competent Court of Law.

It is further ordered that the inter-se seniority of the appointees alongwith the appointees figuring in Government Order No. 154-Home of 2023 dated 27.03.2023, shall be determined in terms of the Rule 10 of Jammu & Kashmir Prosecution Service Recruitment Rules, 2020.




