In terms of Article 168-D of the Jammu & Kashmir Civil Services Regulations, 1956, sanction is hereby accorded to grant of provisional pension in favour of Shri Ghulam Mohi ud Din Ganie, Ex-Special Secretary, Home Department, w.e.f 01.04.2019, who retired on superannuation on 31.03.2019, subject to the condition that the Gratuity and Leave Salary admissible to the retired officer shall remain withheld till the conclusion of Judicial/ Departmental proceedings and passing of final orders.

It is further ordered that illegitimate monetary benefits amounting to Rs.37,97,583/- (Rupees Thirty Seven Lakh, Ninety Seven Thousand, Five Hundred and Eighty Three only) received by the officer during the period of overstayal in Govt. Services, shall be deducted/recovered from the Provisional Pension/ Arrears on account of Provisional Pension accrued to the retired officer, in lump sum as one time settlement.


