Sanction is hereby accorded to the purchase of 187 vehicles, sanctioned by MHA, GoI vide No. 13030/86/2015-K.II(pt) dated: 15.12.2021, by the Director General of Police, J&K alongwith release of additional funds amounting to Rs. 104.00 crore (Rupees one hundred and four crore) only, under Detailed Head 046-Purchase of Vehicles, Sub Head 0957-Internal Security below Major Head 2055-Police in BE 2022-23.

This sanction is subject to the fulfillment of following conditions:

- a) The purchase of vehicles shall be made as per the approval of the MHA, GoI conveyed vide sanction No. 13030/86/2015-K.II(pt) dated: 15.12.2021.
- b) The purchase shall be made after ascertaining reasonability of rates as most economical.
- c) The purchase shall be made through GeM portal/e-tendering and strictly as per provisions/norms of GFR-2017.
- d) The funds shall be utilized for the purpose for which these have been released and no parking/diversion/re-appropriation of funds at any level shall be allowed.
- e) UC's/Red accounts are furnished to all the concerned quarters and Principal Accountant General (A&E), J&K within the prescribed time limit.
- f) The FA/CAO, PHQ shall vouchsafe the availability of funds under the scheme; and
- g) The department is advised to reflect the additionality in Revised Estimates 2022-23.
