**Subject: Adoption of date of birth in respect of Ct. Zakir Hussain,
PID No. EXK-003530.**

Whereas, the Police Headquarters vide the referred letter submitted case of Ct. Zakir Hussain, PID No. EXK-003530, for adoption of his date of birth as 08.11.1976, instead of 01.11.1976, as recorded in his Character Roll. PHQ submitted a certificate issued by the JKBOSE to substantiate the claim of the official and;

02. Whereas, the case was examined and it was observed that the official came to be appointed as constable in J&K Police, in the year 2000, and his date of birth came to be recorded as 01.11.1976, on the 1st page of his Character Roll, without any cutting or mutilation; and

03. Whereas, upon further examination it was observed that the designated committee of the PHQ has without taking into consideration the relevant provisions of the J&K CSR's and J&K Police Manual, recommended the case of the official for adoption of his date of birth as 08.11.1976; and

04. Whereas, the Article 35-AA of J&K Civil Services Regulations Volume-I explicitly lays down that the alteration in DOB can be effected within 05 years from the date of entry into Govt. Service. The official has failed to represent for alteration of his recorded date of birth within the prescribed time limit and the case has been brought to the notice of the Administrative Department after a lapse of almost 02 decades.

05. Now, therefore, the claim of the official namely Ct. Zakir Hussain, PID No. EXK-003530, after having been examined and considered in terms of the relevant rules governing the field, is for the reasons recorded herein above, found devoid of any merit and rejected. The date of birth of the official shall continue to be treated as 01.11.1976, as recorded on the 1st page of his Character Roll.


