The appointee shall report to the Director General of Police, J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994


03.10.22 The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, genuineness of the qualification certificates from the concerned issuing authority are found fake/forged, the claim of the appointee for appointment as constable in J&K Police shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to his unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d. If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.


