In terms of Rule 6(1) of the J&K Civil Services (Medical Attendance-cum-Allowance) Rules, 1990, post-facto sanction is hereby accorded to the reimbursement of medical expenses to the tune of Rs. 3,59,899/- (Three Lakh Fifty Nine Thousand Eight Hundred and Ninety Nine) incurred by HC Hafiza Akhter, PID No. EXJ-971310 of District Police Anantnag, for availing self treatment outside the UT of J&K at Rajiv Gandhi Cancer and Research Institute, New Delhi, in relaxation of rules, subject to the following conditions:

- a. Reimbursement of charges shall be restricted to items/procedures admissible under rules and cost thereof is restricted to the extent of rates as applicable to such items/procedures at AIIMS New Delhi. Reimbursement of the claim is further subjected to the expenditure incurred beyond the package cost available under the AB-PMJAY SEHAT scheme for such treatment.
- b. All relevant medical bills/vouchers are verified from the concerned medical authority of the hospital where from treatment has been taken.
- c. Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.


