In terms of Government Order No. 485-JK (GAD) of 2023 dated 20.04.2023, sanction is hereby accorded to the grant of ex-gratia relief of Rs. 25,00,000/- (Rupees Twenty Five Lakh only) in favour of the NOKs of the deceased Constable Late Joginder Kumar No. 000060102 of 54th Bn. ITBP Force who attained martyrdom on 17.11.2023 in I.E.D Blast during Chattisgarh Assembly Election duty-2023 at Vill Bade Gobra, P.S Manipur, District Gariyaband (Chattisgarh).

This sanction is subject to the following conditions:-

- i. Commanding Officer of the local Unit/formation shall verify full particulars viz. Name/parentage/Residential Address/bank details etc. of the beneficiaries at the time of disbursement of ex-gratia.
- ii. Payment to the beneficiaries shall be made through the concerned Commanding Officer of the local Unit/formation who shall obtain the acknowledgement receipts from the NOKs/beneficiaries and submit the same along with all the necessary documents/details to the Home Department, J&K for its onward submission to the Ministry of Home Affairs, Government of India for reimbursement of the funds well in time.
- iii. The payment shall be drawn by the FA/CAO, Home Department, J&K for making payment to the concerned Competent Authority, enabling them to make payment to the beneficiaries, by debit to **Major Head:**


