
Pursuant to the selection made on the basis of the Competitive Examination as prescribed under Jammu and Kashmir Competitive Examination (Prosecution) Rules, 2021 and on the basis of the recommendations made by the Jammu and Kashmir Public Service Commission, sanction is hereby accorded to the temporary appointment of Ms. Shazia Chawdhary D/O Mohammed Shafi R/O Dodaj, Darhal, Rajouri under the ST/PHC category against the post of Prosecuting Officer (G) in the Jammu and Kashmir Prosecution Service, in the Pay Level-8 (47600-151100), with immediate effect.

The appointee shall be allowed to join in the Directorate of Prosecution, J&K only on the production of the following certificates in original:

1. Date of Birth Certificate.
2. Qualification Certificate(s).
3. Domicile Certificate.
4. Relevant Category Certificate.
5. Any other documents as required under rules.

The candidate shall join within a period of 21 (twenty one) days from the date of issuance of this appointment order, failing which she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

The salary of the appointee shall not be drawn and disbursed unless satisfactory reports in respect of genuineness of various certificates viz. Qualification /Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agency.



This appointment of the selected candidate shall be governed by the following conditions:

- i. The appointment shall be governed by the "New Pension Scheme" notified vide SRO-400 of 2009 dated 24.12.2009.
- ii. The appointee shall be on probation for a period of two years.
- iii. The appointment of the candidate shall be subject to outcome of the writ petition(s), if any, pending before any Competent Court of Law.

It is further ordered that the prescribed training of the appointee shall be organized separately through IMPARD and her inter-se-seniority shall be determined later on.


