- iii. The leave applied by the officer is sanctioned by the competent authority.
- iv. Entry to this effect is recorded in the service book of the officer.
- v. The Dependence of family members on the officer is established under rule.
- vi. Journey to Kerala is performed by the shortest route.
- vii. The entitlement is regulated by the concerned Drawing & Disbursing Officer under rules.

Sanction is also accorded to the grant of (08) days Casual Leave with effect from 17.02.2023, in favour of the officer, with permission to avail intervening Gazetted holidays.


