Sanction is hereby accorded to the temporary appointment of Mr Zakir Hussain Zargar S/o Late HC, Ghulam Mohi-ud-Din Zargar No 487/KP R/o Manigam A/P Tikker Tehsil and District Kupwara, as Constable in the Pay band of Rs. 5200-20200 with the Grade Pay of Rs. 1900/- (Pre-Revised) in J&K Police, in terms of Rule-7 of SRO-43 of 1994 read with SRO-376 of 2017 dated 11.09.2017.

The appointee shall report to the Director General of Police, J&K within a period of 21 days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates in original:-

1. Academic Qualification certificate.
2. Age and Health Certificate.
3. State Subject Certificate.
4. Certificate from the General Managers, DIC concerned and Deputy Director, Employment concerned to the effect that no Loan under Self Employment Schemes has been taken by him.

If, on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be treated to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report about the verification of his Character and Antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the PHQ. He shall furnish an affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, he shall have no right to claim the appointment and his appointment as Constable in the J&K Police shall be deemed to have been cancelled ab- initio.
