**Government Order No: Home - 73 (TSTS) of 2020**  
**Dated: 22.06.2020**

Whereas, the IGP, Kashmir Zone, being the Authorized Officer under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, has issued directions to the Telecom Service Providers(TSPs)/Internet Service Providers (ISPs) to suspend 2G data services in district Srinagar, w.e.f 21.06.2020 (0535 Hrs) to 21.06.2020 (2230 Hrs) ; and

Whereas, the order under reference *inter-alia* mentions about the encounter between the Security Forces and the terrorists in Gillikadal Zunimar village of District Srinagar, leading to neutralization of 03 terrorist & recovery of arms & ammunition. It is also mentioned that there was every likelihood of misuse of data services by the anti-national elements/OGWs to communicate with their sympathizers for mobilizing crowds, and disturb the law and order situation, during & subsequent to the encounter, in the area, warranting issuance of the aforesaid directions, without obtaining approval of the Competent Authority.

Now, therefore, upon consideration of the various aspects, as brought out in the material provided by the Authorized Officer, I, Principal Secretary to the Government, Home Department, being satisfied that there was absolute necessity of issuance of the aforesaid directions by the Authorized Officer, without obtaining prior approval of the Competent Authority, in the interest of sovereignty & integrity of India, the security of the State and for maintaining public order, hereby confirm order No. 714 (TSTS) of 2020 dated 21.06.2020, issued under endorsement No. KZ/CS/PC-Sgr/20/1536-37 dated 21.06.2020, by the Authorized Officer, in exercise of the powers conferred under sub-rule (1) of Rule 2 of the Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017.
