In terms of sub clause(d)(ii) of clause 3 of Jammu and Kashmir Civil Services (Leave Travel Concession) Rules, 2019, notified vide S.O 22 of 2019 dated 31.12.2019, sanction is hereby accorded to the availing of Leave Travel Concession by Shri Masroor Ahmad Mir, SP, Dy. Commandant IR-10th Battalion, for the Block year 2020-2023, to visit Mumbai, with effect from 16.02.2023, subject to the following conditions:

- i. The claim is covered under Jammu and Kashmir Civil Service (LTC) Rules, 2019.
- ii. The officer or his dependents have not availed such concession earlier during the LTC Block 2020-2023.
- iii. The leave applied by the officer is sanctioned by the competent authority.
- iv. Entry to this effect is recorded in the service book of the officer.
- v. The Dependence of family members on the officer is established under rule.
- vi. Journey to visit Mumbai is performed by the shortest route.
- vii. The entitlement is regulated by the concerned Drawing & Disbursing Officer, under rules.

Sanction is also accorded to the grant of 10 days Earned Leave in favour of the officer with effect from 16.02.2023.


