

English. No translators will be provided.

The two weeks session is designed specifically for women in all law enforcement positions to include police, prosecutors, and judges with a desire to further develop their leadership skills. This course is more than a leadership course, it focuses on empowering and improving all aspects of the female leader, to include, leadership, wellness, suicide and crisis awareness, media relations, cyber investigations, corruption, human trafficking, child exploitation, defensive tactics/personal protection and it has an executive panel and flash mentoring with top senior executive women. The course provides a unique opportunity to examine leadership principles from the female law enforcement professional's perspective and is tailored to focus on issues and challenges common to female leaders in law enforcement such as Gender Differences and Understanding Human Behavior, Work Life Balance, and Emotional Intelligence. The course will facilitate open, candid discussions, lectures, case studies, self-directed studies, panel discussions, and exercises to identify and develop solutions to deal with common issues and challenges that all women face globally throughout the law enforcement field.

Training hours are 9 a.m to 5 p.m., five days per week. The specific training days based on the local work week will be coordinated for Unites States Secret Services (USSS) by the Regional Security Office, New Delhi with the CAPT, Bhopal. Training event attire is customary business dress for the event opening and graduation. DS/USSS policies requires training participants to attend the entire event to receive certificate of completion. Because the training value significantly diminishes if a participant is required to perform normal operational duties while attending the training, participants who miss any portion of training, for what ever reason, will not be allowed to return to finish the instructions.

The Embassy request if the list of participants is provided to the Embassy by March 1, 2024. It is vital that BPR&D and CAPT coordinate with the RSO to ensure selection of the most qualified candidates with appropriate skills and experience who will actually utilize this training. The participant names along with biographic information as per the form (copy attached). To provide uninterrupted session, a reliable computer system and internet access for all participants is critical for this session. All participants will be vetted prior to commencement of the course. Only those participants will be allowed to attend whose details have been provided to us.
