



The Academy also conducts capacity-building programs for All India Services, Central Services and other stakeholders on the issues related to forests, wildlife and environment. As part of its mandate to sensitize personnel of other services, the Academy is organising a 3-day training workshop on "Integrated Wetland Conservation and Management" for mid-career and senior-level officers of All India Services and Central Services from 29 to 31 January 2025 at IGNFA, Dehradun.

The Government of India will bear the training expenses of the participants. The Academy will provide boarding, lodging, and other logistics to the participants at Dehradun; however, the travel expenses to and from Dehradun should be borne by the respective state governments.

Wetlands are an important component of landscapes, and their conservation, management and governance have become critical, particularly in urban landscapes, in the context of rapid development and urbanization.
