Srinagar, the 31st of December, 2021

Whereas, the Government of Jammu and Kashmir in exercise of the powers conferred under sub-section (1) of Section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938, vide S.O 445 dated 31.12.2021, has defined the area measuring 3247 Kanals & 17 Marlas, situated at Badheri, Tehsil and District Samba, as per the details indicated at Annexure to the notification ibid, as an area for the purpose of carrying out periodically, field firing and artillery practice for a period of 10 years.

Now, therefore, through the medium of this notice, the Government in pursuance of sub-section (3) of section 9 of the Act ibid, hereby gives notice of its intention to issue on expiry of two months from the date of publication of this notice in official gazette, a notification under sub-section (2) of section 9, authorizing the carrying out of field firing and artillery practice throughout the area specified in S.O 445 dated 31.12.2021 or on any part thereof for the period or periods specified in the notification, as per the agreed Standard Operating Procedure (SOP).
