Whereas, the Government of Jammu and Kashmir in exercise of the powers conferred under sub-section (1) of Section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938, has vide notification S.O 318 dated 08.09.2021, defined the area measuring 82 Kanals & 07 Marlas, under Khasra Nos. 803, 804 & 806, situated at Village Bapli Lote Tehsil and District Udhampur as an area for the purpose of carrying out periodically, Field Firing and Artillery Practice by the Border Security Force (BSF), for a period of 10 years w.e.f 01.03.2020.

Now, therefore, through the medium of this notice, the Government in pursuance to sub-section (3) of section 9 of the Act hereby gives notice of its intention to issue on or after expiry of two months from the date of publication of this notice in official gazette, a notification under sub-section (2) of the said section, authorizing the carrying out of Field Firing and Artillery Practice throughout the whole or any part of the area specified in notification S.O 318 dated 08.09.2021.
