NOTIFICATION

Jammu, the ~~30th~~ ^{31st} December, 2020

S.O. ~~395~~ ³⁹⁹ .- In exercise of the powers conferred by the proviso to section 309 of the Constitution, the Lieutenant Governor hereby makes the following amendments in the Jammu and Kashmir Sainik Welfare (Subordinate) Service Recruitment Rules, 2019; namely:-

1. sub rule (b) of rule 2 shall be substituted by the following; namely:-
“**Board** ‘Board’ means the Jammu and Kashmir Services Selection Board in respect of all posts to be filled in by Direct Recruitment, excluding those to be filled on contractual basis which shall be filled through Departmental Recruitment Board;
2. Proviso to sub rule (3) of rule 5, shall be substituted by the following; namely:-
Provided that all the posts under direct recruitment in Subordinate Service shall be filled through **Jammu and Kashmir Services Selection Board**, excluding those to be filled on contractual basis which shall be filled through Departmental Recruitment Board comprising of the following:-

1	Director Sainik Welfare Department	Chairman
2	Two Zila Sainik Welfare Officers	Members
3	Representatives of the Administrative Department (Not below the rank of Under Secretary)	Member
4	Assistant Director, Sainik Welfare Department	Member Secretary

3. **In rule 6. – (i) for the words and figures “34 years” the words and figures “25 years” shall be substituted.**

(ii) Proviso to rule 6 shall be substituted by the following; namely:-
“Provided that the minimum age limit shall not be applicable to an Ex-servicemen who is granted regular pension (with PPO) after completion of his terms of engagement for re-employment in Sainik Welfare Department.”

4. In Schedule II;

- (a) Class I, Category C, under the column “Method of Recruitment,” for the words and figures “**upto 58 years**” the words and figures “**upto 60 years**” shall be substituted.
- (b) Class II, Category A, under the column “Method of Recruitment”, the following shall be substituted; namely:-
- (i) “50% by promotion from Class-II category “B” from among the persons having not less than three years service as such.
- (ii) 50% by promotion from Class-II category “C” from among the persons having not less than five years service as such.”


