Notification

Srinagar, the 14th October, 2024

S.O. 509.-Whereas requisitioned property comprising of private land measuring 698 Kanals 01 Marla situated at Village Manda and Dasgal, Tehsil Akhnour District Jammu was acquired by the Union Government for defence purpose; and

Whereas, a dispute has arisen about the rate of compensation between the Army authorities and land owners as indicated in the Annexure, "A".

Now therefore, in exercise of the powers conferred by clause (b) of sub-section (1) of section 8 of the Jammu and Kashmir Requisition and Acquisition of Immovable Property Act, 1968, read with clause (13) of the Jammu and Kashmir Reorganization (Removal of Difficulties) Order, 2019, the Government hereby appoint Principal District Judge, Jammu as Ex-Officio Arbitrator to make the award in respect of the said dispute. The Arbitrator shall give his findings within a period of four months from the date of publication of this notification in the Government Gazette.


